InfoPathways - paving the way

InfoPathways, an online teaching resource produced by the UWA Reference Librarians, has recently been accepted into the Association of College & Research Libraries (ACRL) Internet Education Project (IEP). The IEP is a peer reviewed resource of instructional materials created by librarians. Currently only 92 projects world-wide have been accepted.

InfoPathways is an introductory level course which takes students through searching, finding, using, evaluating and presenting information in relation to their university studies. There are six self-paced modules, each of which has specific outcomes chosen from our Information Literacy Curriculum Framework. The modules are interactive, with short exercises and self-tests to help students achieve the outcomes for each module. InfoPathways can be used as a stand-alone course for the individual to follow or as a teaching tool for Librarians. Alternatively specific modules can be embedded within subject specific online information literacy courses.

Retooling the Toolbox

The Information Toolbox now has a new more intuitive interface. The design has been streamlined to make searching and browsing for key library resources easier. Features include:

- An easy to browse list of broad subjects and narrower topics

The Library recently subscribed to Australian Public Affairs - Full Text (APA-FT) currently considered the leading online resource for Australian information.

APA-FT is an online collection of scanned images of articles from more than 300 Australian journals indexed in APAIS, the Australian Public Affairs Information Service produced by the National Library of Australia. The focus is on a on a variety of subject areas including, social science, education, current affairs, business, economics, humanities, health and law.

APA-FT currently contains over 47,000 full text records from 1995 comprising:

- Copyright cleared journals available as PDF images.
- Links to materials available on the World Wide Web.
- Links to Australian e-journals available in the National Library of Australia's PANDORA Archive and permanent links from other services.
- APA-FT is updated monthly.

The Library has purchased online access to Clinical Evidence, a continually updated international source of the best available evidence on the effects of common healthcare interventions. This resource presents concise summaries based on thorough searches and appraisal of the literature.

UWA aims to provide our graduate students with the understanding and skills needed in the professional arena. The Medical and Dental Library has identified Clinical Evidence as one of the best sources used by clinical doctors. Our medical students now use Clinical Evidence as part of their transition from student to medical practitioner.

Farewell Helen - case closed!

Helen Wallace, Business/Law Librarian has left the Library after working here for thirty three years. "It was very much easier in those days, you could just stick a pin in a map and say I want to work there," said Helen, which is just what she did. She wrote to the University Librarian, Leonard Jolley, asking for a job. After some correspondence, he agreed and Helen's first position was as a library assistant in cataloguing. She moved all the way from the Yarra Valley in Victoria to take up the opportunity.

When Helen commenced in 1971, the Reid Library was undergoing a major reconstruction, doubling the size of the building. This is just one of the many transformations that the Library and Helen have undergone. "When I began it was the hippy era and I used to come to work in bare feet, wearing a sarong."

In 1983, Helen became the Loan Services Librarian (Central Services) responsible for loans, photocopying, Interlibrary Loans and the general attendants within the Reid Library. When the Reid was split into the various subject libraries in 1994, Helen

became the Law Librarian. In 2002, she was appointed as the Business and Law Librarian and finished her time at the UWA Library back in the Reid Library Building. Helen has filled acting roles throughout the Library system, including Mathematics and Physical Sciences Librarian, Biological Sciences Librarian and on numerous occasions Associate Librarian.

Helen faced many changes throughout her time here, especially adapting to advances in technology. "Computers have brought vast changes to the

Discounted books negotiated

The WAGUL (West Australian Group of University Librarians) have recently signed a new consortium agreement with Blackwell Book Services (BBS) and DA Information Services.

In July 1998 WAGUL's first consortium agreement for the purchase of monographs and associated cataloguing services came into operation.

In April 2003, a new request for proposal was issued, and sent to major library suppliers seeking a further consortium agreement to replace the existing one. Following analysis of the responses, WAGUL decided to enter into an agreement with DA Information Services Pty Ltd for the supply of monographs from Australasia and Europe, and into an agreement with Blackwell Book Services (BBS) for the supply of monographs from North America.

The consortium agreement signed in November 2003 runs for 3 years and offers significant benefits in terms of discounts on the cost of monographs. Other related services, such as the provision of order and catalogue data which can be loaded into local systems, have improved the overall efficiency of the ordering process.

Melinda Kiss - Iron woman



Melinda Kiss, Library Officer at the Medical and Dental Library, is currently in Forster-Toncurry, New South Wales, competing in the Australian Ironman Triathlon. Melinda is a very keen triathlete and recently took part in the Accenture Series Race (an Olympic pre-selection event). She used the race as an opportunity to train for the national Ironman meet. "It was a good experience to be a part of such a big event ... and the finish chute was great with all those spectators cheering."

Melinda has been with the Library for three and a half years, and has become very adept at balancing exercise and work, with up to 22 hours training per week. She trains before and after work, some days completing a 3 hour ride in the morning and then 2 hours running in the afternoon.

The Ironman event consists of 3.8km swim, 180km cycle and 42.4km run. Competitors have 15 and half hours to complete the course. Melinda will be one of nearly 1,600 competitors ranging in age from 18 to 74. Melinda says she does the event "just for the achievement of finishing and crossing the famous finish line." And she adds "Some big names will be competing this year like Germany's Lothar Ledger and Australia's Chris McCormack. Of course they will be finished before I start the run!"

When asked why she does all this work, Melinda's modest response is "Because I can!"
